PRIVACY POLICY

As a basic principle, the Swiss Federal Data Protection Act (FADP) applies to the processing of your personal data. In certain circumstances, for example if you live in a Member State of the European Union, the European Data Protection Regulation 2016/679 (GDPR) may also apply.

This Policy applies as of 25th May 2018.

This Privacy Policy describes how the data is processed by Aubonne Netball Allstars (ANA) in line with GDPR and the Swiss FADP standards.

The personal data we collect and its use will be as follows:

Year of birth	• ANA registration list used to record who is a member and how to contact each person. • Team sheets for matches and tournament • Quickbooks for invoicing purposes
Residence	• ANA registration list used to record who is a member and how to contact each person. • To request subsidies from the commune (Swiss only) • In some circumstances address is kept on quickbooks for invoicing purposes

We may have reason to share your data with :

- Swiss Netball for match play events.
- Other netball clubs within Switzerland for arranging match plays/tournaments.

How we protect your data and for how long we will keep your information

We protect your data by keeping it on a secured, password protected spreadsheets on Google Drive. Access is restricted to the 3 committee members and the Head Coach. The privacy policy for Google can be found at <http://www.google.com/privacy>. We collect your data

Personal data will be retained for as long as is needed.
